I understand that it is normally recommended that cleaning be done with antibacterial hand soap should be used. I also agree that any touch up work needed, due to my own negligence, shall be done at the standard shop rates. I understand that if I have dark skin the colors will not appear to be as brilliant as if my skin were light colored.
